In these terms and conditions references to "you" and "your" include the first named person on the booking and all persons on whose behalf a booking is made or any other person to whom a booking is transferred or added.

BAGGAGE POSSESSION AND VALUABLES

You are responsible to ensure that all your possessions are safe at all times. You must ensure that your insurance makes sure you are adequately covered.

We will not be held responsible for your baggage and possessions.

PRICES

All prices shown are in GBP (Great British Pounds). Any price conversions shown are provided for the purpose of comparison only and you should contact your bank or card issuer for more accurate rates.

ACCURACY

We always endeavor that any information and prices on our website or any marketing material are accurate, however, occasionally changes and errors occur and we reserve the right to correct any prices and other details in such circumstances. CANCELLATION POLICY

If you choose to cancel or leave your program for any reason, all booking fees, deposits and payments are non-refundable. It is your responsibility to ensure that your insurance policy provides adequate cover in this event. No refund will be payable by Sporting Gap Years Limited if forced to cancel due to circumstances beyond its reasonable control and which could not have been foreseen or avoided even if all due care had been exercised, including but not limited to war or threat of war, riot, civil unrest or insurrection, strike, lockout or other industrial action, act of terrorism, act of God, fire, flood or other adverse weather conditions.

TRAVEL INSURANCE

Traveling without insurance is a massive risk and many countries require this as compulsory. It is a requirement with Sporting Gap Years Limited that you have adequate travel insurance.

We recommend that you purchase insurance when you book your trip because then you should be covered for trip cancellation. Please ensure you send us proof of insurance 30 days before departure. PASSPORTS AND VISAS

Inform Sporting Gap Years Limited of any changes which may affect your programme immediately.

Your club/academy may change before or during your programme.

You will be responsible for your own travel which is required during the programme.

We do not accept any responsibility for any of our clubs actions, their members, players or coaches actions.

CHANGES

As we plan your programme many months before your departure we may occasionally have to make changes or cancel your booking and we reserve the right to do so at any time.

COMPLAINTS

If you wish to make a complaint you must ensure you contact us immediately. We will investigate any complaints and try to resolve them as quickly as possible.

ACCOMMODATION
